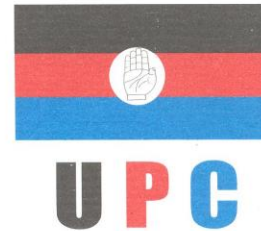

Further to the Notice which appeared on pages 40 and 41 of the New Vision newspaper of Thursday 6th August 2015 and in accordance with Article 12.3(3) of the UPC Constitution, the Party President invites you to participate in a National Council meeting beginning on Thursday 13th through to Saturday 15th August 2015. Reporting will be at Uganda House, 6th Floor, Kampala on Thursday 13th August starting at 8:00am-1:00pm. The first session starts at 2:00pm on the same day.

Mission: A social democratic party that seeks to safe guard national independence and promote national unity, equality, equity and human rights for all.

Vision: An independent, united, democratic, just, peaceful and prosperous nation, where all its citizens have equal opportunities and equitable access to national resources.

Agenda:

- Approve appointment of Cabinet members in accordance with Article 14.3(2)(b) so that the Party has a fully constituted house
- Elect Electoral Commissioners for appointment by the Party President in accordance with the Delegates Conference Resolution and Article 21.1. In this, the PP advised that Cabinet sets terms of reference
- Approval of Roadmap and Guidelines for Party Primaries in accordance with Articles 12.2(8) & 23.1 and Delegates Conference Resolution.
- Adopt Terms of Reference and Elect seven members of the Mediation and Reconciliation Committee in accordance with the Delegates Conference Resolution. The committee is meant to heal and promote reconciliation within the Party
- Approval of the UPC Manifesto for the 2016 General Elections as a delegated authority from the Delegates Conference.
- The Democratic Alliance Protocol and UPC's participation therein.
- The relationship between UPC, the Milton Obote Foundation (MOF) and Uganda House in cognizance with Article 12.2(6).
- Approval of Membership and subscription fees payable as per Articles 3.2(5), 3.5, 4.1 and 4.2. as part of Party funds mobilization
- Approval of Rules and Procedures for the Disciplinary Committee in accordance with Article 24.1(2) & (3) and 12.2(10).
- The establishment of Youth and Women's Leagues in line with the 2011 National Council Resolution.
- Admission of Honorary Members in accordance with Article 3.3(1).
- Issuance of Guidelines to District Executive Committees for the organization, establishment and supervision of Party Branches in accordance with Article 11.6(7).
- Approve policies, programmes and activities of the Party in accordance with Article 14.2(1).
- Approve the establishment of Departments and paid staff at the Party Headquarters in accordance with Articles 12.2(5) & (7) to streamline administration at the Party secretariat
- Consider and approve the Party Budget as per Article 12.2(2).

- Consider and approve Report on Party Finances and audited accounts as per Article 12.2(3).
- Approve Financial Guidelines for the Party.
