His term expired on 13<sup>th</sup> March 2015. During his tenure he failed to convene a single Delegates' conference and postponed the last two he announced after his term had expired, the last one "indefinitely".

- UPC calls for peaceful General Elections and reminds all citizens that Uganda belongs to all its people and they need to live in harmony to forge a way of framing the destiny of our Country in peace.
- 4. Uganda Peoples Congress would like to inform all its members that despite the current court cases brought against it by the last administration and the Milton Obote Foundation, the Party leadership still extends its olive branch to those that may have been caught up in

On the 21<sup>st</sup> December 2015, UPC appeared in Civil Division of the High Court in a case brought against it by Olara Otunnu and 6 others, it was apparent that the plaintiffs had forged a court document and smuggled into the file claiming that they had served the Defendants' Lawyers, on scrutiny from Justice Yasin Nyanzi, it was discovered that the plaintiffs' lawyer had forged and smuggled a mediation summary to the file without serving or consulting the defendants and their lawyers.
- These actions not only undermine the process of court but shows unwillingness on the part of the plaintiffs' to pursue mediation and dialogue. UPC still maintains its willingness to engage all its members.
- Uganda Peoples Congress would like to categorically state that court never issued any order whatsoever evicting anybody from its Headquarters as is being peddled by certain individuals belonging to the last administration.

UPC Party President Hon. Jimmy Akena is in office and performing his duties as mandated by the Party Constitution. Therefore we inform all members of the Party and Ugandans at large that no UPC candidates will be affected by the court decision of 11<sup>th</sup> December 2015.
